Pursuant to your order dated April 15, 2015, attached hereto as Exhibit A is a list of cases potentially affected by the following alleged improper practices:

(1) Improper Engineering Practices

The cases listed on Exhibit A have potentially been affected by improper engineering practices, including, but not limited to:

- Improper alteration of reports prepared by licensed engineers without the engineers' authority or consent;
- Use of unlicensed engineers to inspect properties for flood damage;
- Use of uncertified engineering companies to perform engineering analyses;
- Improper attempts to obtain ratification from engineers on improperly altered reports; and
- Inadequate investigation by and/or collusion with WYO carriers, adjusting companies, and FEMA regarding these improper engineering practices.

Should all outstanding matters not be resolved by April 27th, Plaintiffs are requesting evidentiary hearings in the cases listed on Exhibit A to resolve these issues and determine if monetary and/or evidentiary sanctions are appropriate.

Additionally, Plaintiffs request the Court allow Plaintiffs to conduct at least the following discovery regarding these improper engineering practices:

- **Depositions**
 - Plaintiffs request the Court allow Plaintiffs to depose at least the following Representatives and Employees from HiRise Engineering, P.C.:
 - Corporate Representative(s) of HiRise Engineering, P.C. on institutional topics

- Plaintiffs request the Court to allow Plaintiffs to send depositions on written questions to all individual engineers who consulted on Hurricane Sandy claims for HiRise Engineering, P.C., U.S. Forensic, LLC, or United Technical Consultants, and request the following:
 - Records of all payments from [WYO / Adjusting Company];
 - All invoices for engineering services sent to [WYO / Adjusting Company];
 - All documents drafted, prepared, reviewed, changed, altered or transmitted in any part by you regarding Hurricane Sandy;
 - All emails and correspondence with [WYO / Adjusting Company] regarding Hurricane Sandy;
 - Any indemnity agreement and/or contract between you and [WYO / Adjusting Company];
 - All draft engineering reports prepared by you regarding any Hurricane Sandy flood damage;

- All final engineering reports prepared by you regarding any Hurricane Sandy flood damage;
- **Case Specific Written Discovery**
 - Plaintiffs request the Court to allow Plaintiffs to send the following case specific written discovery requests in each of the affected cases prior to the evidentiary hearing scheduled by the Court:
 - All engineering reports (draft and finals) related to Plaintiffs' claim and/or property.
 - All emails and correspondence regarding Plaintiffs' claim and/or Property.
 - All emails and correspondence between [Engineer] and any representative agent of [Engineering Company].
 - All emails and correspondence between [Engineer] and Defense Counsel.
 - All photos and field notes taken by [Engineer] of Plaintiffs' home.
 - All documents drafted, prepared, reviewed, changed, altered or transmitted in any part by [Engineer] regarding Hurricane Sandy.
 - Records of all payments to [Engineer].
 - Records of all payments to [Engineering Company].
 - Hourly billing records for any charge submitted to FEMA for Hurricane Sandy work.
 - Receipts for expenses such as travel, site inspections, and mileage submitted to FEMA.
 - All documents reflecting any internal investigation conducted into allegation of fraud or improper engineering practices arising from Hurricane Sandy.
 - Any document [WYO] contends supports the suggestion, if any, that the Plaintiffs caused or contributed to their losses / damages through failure to mitigate, spoliation, or any other manner.
 - Any document that reflects a change in policy, practice, or procedure--if any--that you instituted or amended as a result of the Hurricane Sandy litigation, or the allegations raised in the live complaint.
 - Any document you contend supports the suggestion, if any, that you were not aware of the engineering reports made the basis of this lawsuit, including the original drafts and/or their subsequent altering / amendments.
- **Institutional Written Discovery**
 - Plaintiffs request the Court to allow Plaintiffs to send the following institutional written discovery requests in each of the affected cases prior to the evidentiary hearing scheduled by the Court:
 - All [U.S. Forensic/HiRise/UTC] reports regarding Hurricane Sandy claims in New York with corresponding invoices;
 - Any indemnity agreement and/or contract between [U.S. Forensic/HiRise/UTC] and [WYO / Adjusting Company] and/or [Defense Counsel];

- All documents drafted, prepared, reviewed, changed, altered or transmitted in any part by [U.S. Forensic/HiRise/UTC] regarding Hurricane Sandy;

- All billing records for work performed by [U.S. Forensic/HiRise/UTC];
- Records of all payments to [U.S. Forensic/HiRise/UTC];
- List of all engineering companies used by [WYO / Adjusting Company] to evaluate flood damage caused by Hurricane Sandy;
- The number of claims on which [WYO / Adjusting Company] hired an engineer to evaluate Hurricane Sandy flood damage;
- All communications between [WYO Company], [Engineering Company], [Adjusting Company] and/or FEMA;
- All requests for indemnity from [WYO Company] to FEMA; and
- All bills/invoices that reflect charges or claims to FEMA for services rendered by [WYO Company], [Engineering Company] and/or [Adjusting Company].
- Documents (including electronic documents or information) relating to the screening, training, hiring, managing, supervision, and/or quality control of employees at HiRise Engineering.
- The personnel files for Pappalardo, Skartsiaris, Smaragdas, Garove, Grover, Grogan, and others responsible, in whole or in part, for the drafting, discussion, forwarding, or other connection to any engineering report from HiRise, United Technical Consultants, and/or U.S. Forensic. Protected information such as HIPPA information or social security numbers may be redacted.
- All training, policy, or other directive documents relating to the handling of claims and/or engineering reports, communications with engineers, and or the processing of claims.
- All documents received from any governmental entity, agency, or quasi-agency (including, but not limited to FEMA) that relate to [WYO's] handling of claims including those of Hurricane Sandy.
- Any document you contend supports the suggestion, if any, that [WYO] or [WYO] employees were unaware of the altered engineering reports, or where otherwise not responsible for their alteration or editing.

(2) Improper Estimating Software Practices

The cases listed on Exhibit A have potentially been affected by improper estimating software practices, including but not limited to:

- Wrongful exclusion of material sales tax;
- Wrongful exclusion of overhead and profit; and
- Inadequate investigation by and/or collusion with WYO carriers, adjusting companies, and FEMA regarding these improper estimating software practices.

Plaintiffs believe any estimate of Hurricane Sandy damage generated in through Simsol Insurance Services, Inc. and/or Simultaneous Solutions, Inc. may contain software discrepancies. Plaintiffs reserve the right to explore this issue in an evidentiary hearing even though the case and/or issue may not be listed on Exhibit A hereto.

Should all outstanding matters not be resolved by April 27th, Plaintiffs request evidentiary hearings in the cases listed on Exhibit A to resolve these issues and determine if monetary and/or evidentiary sanctions are appropriate.

Additionally, Plaintiffs request the Court allow Plaintiffs to conduct at least the following discovery regarding these improper estimating software practices:

- Plaintiffs request the Court to allow Plaintiffs to depose at least the following Representatives:
 - Corporate Representative of Simsol Insurance Services, Inc.
 - Corporate Representative of Simultaneous Solutions, Inc.
 - Corporate representative from each WYO carrier and/or Adjusting Company whose adjusters used Simsol Insurance Services, Inc. or Simultaneous Solutions, Inc. to estimate Hurricane Sandy flood damage.

- Plaintiffs request the Court to allow Plaintiffs to request the following documents from Simsol Insurance Services, Inc. and Simultaneous Solutions, Inc. through a subpoena duces tecum attached to the oral deposition notice of the corporate representative, or in the alternative through depositions on written questions, and request the following:
 - Copy of all price lists used to prepare estimates and building and repair costs associated with Hurricane Sandy
 - From 2011 to present, all written and electronic communications, including but not limited to, correspondence (notes, comments, claim history, update statuses, communications, action items, notifications, and/or assignments), emails (regardless of system being used), facsimiles, memorandum, and/or notes, between, generated by and/or received by the following entities, Simsol Insurance Services, Inc., Simultaneous Solutions, Inc., [WYO CARRIERS] for the purpose of generating estimates and establishing and updating building and repair costs associated with Hurricane Sandy property claims in New York.
 - All contracts and licensing agreements between Simsol Insurance Services, Inc. and/or Simultaneous Solutions, Inc. and [WYO / Adjusting Company].
 - All correspondence, whether hand written, typed, computer generated, or emails between Simsol Insurance Services, Inc. and/or Simultaneous Solutions, Inc. and [WYO / Adjusting Company] regarding the inclusion of materials sales tax when estimating the cost to repair flood damage in New York from January 1, 2010 to December 31, 2013.
 - All instructions, memoranda, guidelines and/or other communications, whether hand-written, typed, computer-generated regarding the inclusion of material sales tax on estimates written with Simsol Insurance Services, Inc. and/or Simultaneous Solutions, Inc. pricing when estimating the cost to repair flood damage in New York from January 1, 2010 to December 31, 2013.

- For any survey/survey campaign of the prices in New York completed by Simsol Insurance Services, Inc. and/or Simultaneous Solutions, Inc. (including any subsidiary or related entities, if any), from January 1, 2010 to December 31, 2013, please produce the following:
 - All correspondence, whether hand written, typed, computer generated, or emails between Simsol Insurance Services, Inc. and/or Simultaneous Solutions, Inc. and the person/company who was contacted for the survey;
 - The raw data behind the final survey results;
 - The final survey results, and
 - All correspondence, whether hand written, typed, computer generated, or emails between Simsol Insurance Services, Inc. and/or Simultaneous Solutions, Inc. and [WYO], (including any subsidiary or related entities or employees of any subsidiary or related entities, if any), regarding the survey and the survey results.
- All correspondence, whether hand written, typed, computer generated, or emails between Simsol Insurance Services, Inc. and/or Simultaneous Solutions, Inc. and [WYO / Adjusting Company] regarding [WYO / Adjusting Company] ability to revise/edit the prices reflected in the Simsol Insurance Services, Inc. and/or Simultaneous Solutions, Inc. Price Lists published by Simsol Insurance Services, Inc. and/or Simultaneous Solutions, Inc. from January 1, 2010 to December 31, 2013.
- All instructions, memoranda, guidelines and/or other communications, whether hand-written, typed, computer-generated or email, meant to guide, or limit State Farm's ability to revise/edit the roofing prices reflected in the Simsol Price Lists published by Simsol Insurance Services, Inc. and/or Simultaneous Solutions, Inc. from January 1, 2010 to December 31, 2013.

- Any and all operation guides, user manuals, instructions, FAQs, memoranda, or similar documents or other information, regardless of form, regarding Simsol Insurance Services, Inc. and/or Simultaneous Solutions, Inc. This request is limited to all documents, materials, or other information produced, exchanged, or otherwise disseminated from January 1, 2011 to the present.
- Any and all records and correspondence used or referenced by Simsol Insurance Services, Inc. and/or Simultaneous Solutions, Inc. to verify that the prices included in Simsol Insurance Services, Inc. and/or Simultaneous Solutions, Inc. Price Lists, from January 1, 2011 to the present, were accurate based on local market conditions in New York.

Plaintiffs reserve the right to request additional discovery.

Request for Relief

Plaintiffs have detailed above the requested relief sought on the cases listed in Exhibit A. Plaintiffs reserve the right to request additional relief from the Court after an evidentiary hearing and/or discovery is conducted.

Please note that the requested relief in the following cases listed on Exhibit A differs from that which is requested above:

- **Cause No. 2:14-cv-02568; *Duhl v. U.S. Department of Homeland Security, et al.*** – Plaintiff is seeking the full amount of his loss (remaining policy limits), additional amounts under the terms of the policy relating to personal property loss, recovery of expenses of engineers, reasonable attorney’s fees, adjusters’ fees, consulting and accounting fees.
- **Cause No. 1:14-cv-06562; *Cohn v. FEMA and NFIP*** – Plaintiff is seeking payment of full policy limits.
- **Cause No. 2:14-cv-06430; *Carey v. American Bankers Ins. Co. of Florida*** – Plaintiff is seeking payment of full policy limits.
